# Nursery Admissions Policy – 2023

## 15 and 30 hour provision available

From September 2018, responsibility for admission to the nursery lies with Stapleford Primary School, who will admit a maximum of 12 children in the academic year. The school will have two intakes:

- September intake for children born between 1 September and 28 February
- January intake for children born between 1 March and 31 August

All nursery children will be encouraged to attend five mornings a week (15 hours) to maximise learning opportunities. <u>Stapleford Primary School will be offering 30 hours of nursery provision</u>. Attendance at the Nursery does not guarantee subsequent admission into the main school for primary education.

The Local Authority no longer coordinates the admissions for nursery in Hertfordshire schools. All applications **must** be made on the school's own application form. Applications may be made by downloading the form from the <u>school</u> <u>website</u> and emailing it to the school or by completing a paper copy available from the school office. Parents/carers are requested to complete our Supplementary Information Form (SIF) and return it to the school office by the date given below. If a SIF is not completed the Governing Body will apply their admission arrangements using the information submitted on the application form only, which may result in your application being given a lower priority.

The official opening date for nursery admission application forms is 1<sup>st</sup> January 2022 and applications will close on 28<sup>th</sup> February 2022. Allocations will be made at the beginning of March and parents will subsequently be informed. Following the initial allocation, parents will be expected to accept or reject the offer within two of weeks of the place being offered in order that remaining places can be allocated. Any remaining places will be allocated in accordance with the admissions criteria outlined below.

### HOW PLACES ARE OFFERED

Children who have an Education, Health and Care Plan which names the school will be admitted to the school. In the event of there being more applications than available places, the following oversubscription criteria will be applied, in order:

1. Children looked after and children who were previously looked after, including those who appear (to the admission authority) to have been in state care outside of England, and ceased to be in state care as a result of being adopted or became subject to a child arrangements order or a special guardianship order.

2. Children who have a sibling in the school at the time of entry.

3. Children of families who live in our three ecclesiastical parishes of Stapleford, Bramfield and Waterford and whose family (parents and children) has attended any Christian church at least once a month for the year prior to the admission cut-off date (a letter from the priest/minister/vicar will be required to support this).

4. Children of parents living within the ecclesiastical parishes of Stapleford, Bramfield and Waterford.

5. Any other children.

#### Tie Break

Where the application of the above criteria results in a situation where there are more children with an equal right to admission to the school than the number of available places, the following tie-break will be applied: A 'straight line' distance measurement is used in all home to school distance measurements. Distances are measured using a computerised mapping system to two decimal places. The measurement is taken from the AddressBase Premium address point of your child's house to the address point of the school. AddressBase Premium data is a nationally recognised method of identifying the location of schools and individual residences. When there is a need for a tie break where two different addresses are the same distance from the school, in the case of a block of flats for example, the lower door number will be deemed nearest as logically this will be on the ground floor and therefore closer. If there are two identical addresses of separate applicants, the tie break will be random. Every child entered onto the

HCC admissions database has an individual random number assigned, between 1 and 1 million, against each preference school. When there is a need for a final tie break the random number is used to allocate the place, with the lowest number given priority.

The governors cooperate with the fair access policies of the LA. Children admitted under the Fair Access Protocol will be prioritised above those on the CI list and can be admitted over the Published Admissions Number PAN.

Every effort will be made to accommodate twins and other 'multiple birth' applications in all year groups. Where the last available place has been offered to a twin or multiple birth child the second twin or other sibling(s) will be offered places as exceptions to the Class Size rule.

#### Children out of year group

The school's policy is for children to be educated within their correct chronological year group, with the curriculum differentiated as necessary to meet the needs of individual children. This is in line with DfE guidance which states that "in general, children should be educated in their normal age group". If parents/carers believe their child(ren) should be educated in a different year group they should, at the time of application, submit supporting evidence from relevant professionals working with the child and family stating why the child must be placed outside their normal age appropriate cohort. DfE guidance makes clear that "it is reasonable for admission authorities to expect parents to provide them with information in support of their request – since without it they are unlikely to be able to make a decision on the basis of the circumstances of the case". The school's governing body, as the relevant admission authority, will decide whether the application will be accepted on the basis of the view of parents, the headteacher, the child's social, academic and emotional development and whether the child has been previously educated out of year group. There is no guarantee that an application will be accepted on this basis. If the request is not accepted but a place is offered in the normal year group this does not constitute a refusal of a place and

there is no right to an independent statutory appeal. Similarly, there is no right of appeal for a place in a specific year group at a school. The internal management and organisation of a school, including the placement of pupils in classes, is a matter for the Headteacher and senior leadership of the school.

Category 1 Places are allocated to children in public care according to Chapter 7, Section 2 of the School Admissions (Admission Arrangements and Co-ordination of Admission Arrangements) (England) Regulations 2012. These children will be prioritised under rule 1.

Highest priority will also be given to children who were previously looked after, including those looked after outside England, but ceased to be so because they were adopted, or became subject to a child arrangement order or a special guardianship order.

A "child looked after" is a child who is:

a) in the care of a local authority, or

b) being provided with accommodation by a local authority in the exercise of their social services functions (section 22(1) of The Children Act 1989) All children adopted from care who are of compulsory school age are eligible for admission under rule 1.

Children in the process of being placed for adoption are classified by law as children looked after providing there is a Placement Order and the application would be prioritised under Rule 1.

Children who were not "looked after" immediately before being adopted or made the subject of a child arrangement order or special guardianship order, will not be prioritised under rule 1.

<sup>1</sup> Child arrangements order Under the provisions of the Children and Families Act 2014, which amended section 8 of the Children Act 1989, residence orders have now been replaced by child arrangements orders which settle the arrangements to be made as to the person with whom the child is to live.

<sup>2</sup> Special guardianship order Under 14A of The Children Act 1989, an order appointing one or more individuals to be a child's special guardian or guardians.

Children previously looked after abroad and subsequently adopted will be prioritised under Rule 1 if the child's previously looked after status and adoption is confirmed by Hertfordshire's "Virtual School".

The child's previously looked after status will be decided in accordance with the definition outlined in The Children & Social Work Act 2017:

i. to have been in state care in a place outside England and Wales because he or she would not otherwise have been cared for adequately, and

ii. to have ceased to be in that state care as a result of being adopted.

A child is in "state care" if he or she is in the care of, or accommodated by -

(a) a public authority,

(b) a religious organisation, or

(c) any other organisation the sole or main purpose of which is to benefit society.

Category 2 Sibling – a sibling is defined as: the sister, brother, half brother or sister, adopted brother or sister, child of the parent/carer or partner or a child looked after or previously looked after<sup>1</sup> and in every case living permanently<sup>2</sup> in a placement within the home as part of the family household from Monday to Friday at the time of this application. A sibling must be on the roll of the named school at the time the younger child starts.

If a place is obtained for an older child using fraudulent information, there will be no sibling connection available to subsequent children from that family.

<sup>1</sup> Children previously looked after are those children adopted or with a special guardianship order or child arrangements order. This definition was amended following a determination by the OSA in August 2014.

<sup>2</sup> A sibling link will not be recognised for children living temporarily in the same house, for example a child who usually lives with one parent but has temporarily moved or a looked after child in a respite placement or very short term or bridging foster placement.

Categories 3 Home Address

Please note that evidence of permanent residency at the quoted address may be sought.

('Permanent' means that the child has lived at that address for at least a year and/or the family own the property or have a tenancy agreement for a minimum of 12 months.)

The website <u>http://www.achurchnearyou.com</u> can be used to check parish of residence.

A Christian church is defined as one which is a member of Churches Together in England or the Evangelical Alliance.

#### **Continuing Interest (Nursery places)**

After places have been offered, governors will maintain the school's continuing interest (waiting) list. A child's position on a CI list will be determined by the admission criteria outlined above and a child's place on the list can change as other children join or leave it. The school will contact parents/carers if a vacancy becomes available and it can be offered to a child. A continuing interest list will be maintained until the end of the summer term of 2023 - 2024. Late applications, will go onto this list in a position determined by the criteria.

#### Fraudulent applications:

The school, will do as much as possible to prevent applications being made from fraudulent addresses. Address evidence is frequently requested, monitored and checked and school places will be withdrawn when false information is deliberately provided.
